**PPC MEMBERS EXTENDING APPOLOGIES**

**The meeting was called to order at 2:10 pm on Aug 12 2021. The PPC decisions for each item on the agenda is recorded below:**

**1. PPC-2021-HSA-003-RFP Request by the Health Service Authority to replace ageing Waste Water System.**

The PPC reviewed the submission and voted **to approve** the request.

A brief discussion was held between The PPC, Dawn Cummings, Caswell Walford, Christopher McNamee, and Trenton Forman, concerning the replacement of the ageing Waste Water System at HSA.

The HSA Panel explained that the Waste Water infrastructure was in a poor state of repair, and due to significant growth, the existing plant had passed its useful life. Currently, it does not meet environmental standards, the parts are difficult to source, and they are unable to secure the level of compliance that is generally expected.

**2. PPC-2021-EBC-004-RFP Request by CI Regiment for formal dress attire.**

The PPC reviewed the submission and voted **to approve** the request.

A brief discussion was held between The PPC, Colonel Watson and Lt Farley, concerning the request for formal dress attire for the CI Regiment.

The CIR Panel explained that they were in need of formal dress uniforms for ceremonial/state functions, and that the multi terrain camouflage uniforms they currently wore, were not aligned to the mandate in keeping with recognized professional and international standards. The uniforms would be kept on compound in a secured environment, and would be for use by all recruits.

**3. PPC-2020-HECH-018-DA Request by HECH for landscaping package for the Long Term Mental Health Facility.**

The PPC reviewed the submission and voted **to approve** the request.

A brief discussion was held between The PPC, Niasha Brady, and Dennis Harris, concerning the square footage to be landscaped, the number of cottages on the property, and the proposed completion date of the project.

**4. PPC-2021-HECH-037-DA Request for Ongoing Construction on the Long Term Mental Health Facility (Phoenix Construction)**

The PPC reviewed the submission and voted **to approve** the request.

A brief discussion was held between The PPC, Niasha Brady and Dennis Harris concerning the ongoing works at the Long Term Mental Health Facility.

One PPC Member voted against the project.


**6. PPC-2021-MRCU-2002-3/4/6/7 Request by MRCU for the establishment of Biennial purchase contracts.**
