The meeting was called to order at 2:13 pm on Jul 14 2022. The PPC decisions for each item on the agenda is recorded below:

1. PPC-2022-UCCI-017-RFP Request by UCCI to Replace Student Info System

The PPC reviewed the submission and voted to approve the request.

A brief discussion was held by The PPC, J.D Mosley-Matchett and Simon Ashdown, concerning the bidders, the contract cost, and the budget.

Mr, Ashdown stated that the company would be shadowing the existing system during the transition, and that they were confident in the successful bidder, because they are a well-established student information service provider.

The PPC requested ongoing progress reports, and also recommended that the system should not be paid in full until implemented.

2. PPC-2022-CIAA-024-RFP- Request by CIAA FOR ATM Maintenance

The PPC reviewed the submission and voted to approve the request.

A brief discussion was held by The PPC, Wayne DaCosta, Sean Bridle, and Mark Whiteside, concerning the outsourcing of services, and the possibility of in-house services at ORIA, in the near future.

The Panel stated that the company would be performing day to day task at the airport (various inspections), and that both CIAA and the preferred bidder were covered by liability insurance.

3. PPC-2022-NRA-020-RFP Request by NRA for the installation of drainage for ACR

The PPC reviewed the submission and voted to approve the request.

A brief discussion was held by The PPC, Brian Chin Yee and Denis Thibeault, concerning the construction and laying of the culverts, the pre tender estimate, acceptance by MRCU, and the budget.

4. PPC-2021-HSA-044-RFP Request by HSA for Medical & Surgical supplies

The PPC reviewed the submission and voted **to approve** the request.

This request was deferred previously by the PPC on April 14th, and also on May 5 2022.

A brief discussion was held between The PPC, Dr Delroy Jefferson, Ronnie Dunn, Nadia Richards and Beverley Manderson, concerning the local suppliers, price changes, and the market conditions since Covid19.

5. PPC-2021-HSA-045-RFP Request by HSA for Pharmaceutical Supplies

The PPC reviewed the submission and voted **to approve** the request.

This request was deferred previously by the PPC on April 14th, and also on May 5 2022.

A brief discussion was held between The PPC, Dr Delroy Jefferson, Ronnie Dunn, Nadia Richards and Beverley Manderson, concerning the quality, safety, and standard of the products, past experiences with the suppliers, price and market changes since Covid19.

The PPC stated that on review they found the material presented to be flawed, and recommended that they revamp/improve their scoring criteria, and also requested proof of a local supplier being an authorized distributor of pharmaceuticals.
