PPC-2024-DOT-076-RFP Request for Canadian Media & Buying Services.

The PPC reviewed this application and voted to **approve** this request on November 13 2025.

A brief discussion was held between The PPC, Rosa Harris, Gary Hendricks- Dominquez, Ricardo Smith, Racquel James-Weise and Gabrielle Beckford, concerning the background of the project, the preferred vendor, the contract cost, and the retainer.

PPC-2025-CSD-054-RFP – Request for Network Remote Access Switches.

The PPC reviewed this application and voted to **approve** this request on November 13 2025.

A brief discussion was held between The PPC and Mr. Kerry Christian, concerning the consensus meeting and recommended average, the scoring, and the bidders.

PPC-2025-CIAA-040-RFP - Request for Construction of Tour Group Assembly Area/Band Stand.

The PPC reviewed this application and voted to **approve** this request on November 13 2025.

A brief discussion was held between The PPC, Nicholas Johnson, Eimer Powery and Mark Whiteside, concerning the bidders, the proposed site, and the scoring.

PPC-2025-CIAA-023-RFP – Construction of Approach Control Module Bldg.

The PPC reviewed this submission and voted to **approve** this request on November 13th 2025, **pending** a BAFO exercise being conducted.

A brief discussion was held between The PPC and Mr. Roy William, concerning the background of the project, the budget shortfall, the preferred vendor, the specifications, and the pre-tender estimate.

Mr. Williams stated that the shortfall would be covered by CIAA, and that the preferred vendor presented well, had an experience team, with exceptional technical expertise.

PPC-2025-DES-045-RFP- Request for Bus Transportation for Government Schools.
