PPC MEMBERS EXTENDING APPOLOGIES

The meeting was called to order at 2:13 pm on May 5 2022. The PPC decisions for each item on the agenda is recorded below:

1. PPC-2021-CIAA-059-RFP CIAA request for the Airport Development Project.

The PPC reviewed the submission and voted **to approve** the request.

A brief discussion was held by The PPC, Roy Williams and Nicholas Johnson concerning the evaluation (EPC), the ranking, bidders, and the procurement process.

The PPC instructed the Panel that the project was approved pending submission of letters from two of the evaluators of the project.

Neyka Webster excused herself from this item.

2. PPC-2022-OCP-010-RFP Request by OCP for janitorial services.

The PPC reviewed the submission and voted **to approve** the request.

A brief discussion was held by The PPC, Jody Ann Moore, and Donna Daley Miller concerning the budget, the locations being captured, and the commencement of the contract.

The PPC instructed the Panel that the project was approved pending written confirmation of pricing for Group 2.

3. PPC-2022-HSA-009-RFP Request by HSA for MRI concession service.

A brief discussion was held by The PPC, Ronnie Dunn, Nadia Richards and Pamela Duncan Vaughn concerning the budget, the estimate, discounted payments, inflation, and time value associated with money,

4. PPC-2022-HSA-016-DA Request by HSA to paint the exterior walls of the facility. (Resubmission)
